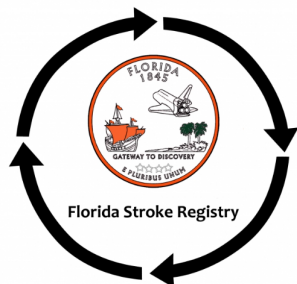

Through this interface, a user may select hospital dashboard metrics and data quarters to see their performance visualized in charts and graphs. There is still an option to downloading the dashboards as static quarterly PDF reports.

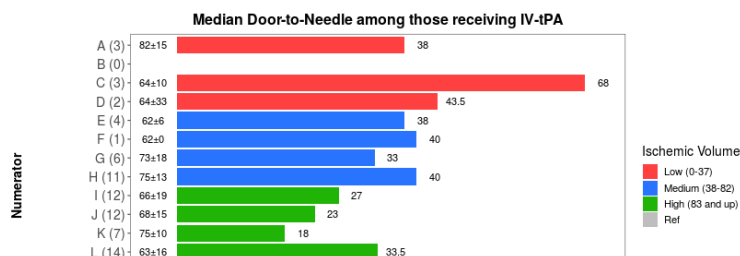


Florida Stroke Registry: Florida County Regional Dashboards

International Stroke Conference (ISC) 2020

February was a busy month for the FSR team, as several of our colleagues traveled to Los Angeles, California to present at the International Stroke Conference (ISC). Dr. Ralph Sacco, Chairman of the University of Miami Department of Neurology and head of the Florida Stroke Registry, presented at the opening plenary celebrating the 50th anniversary of the AHA journal *Stroke*, to which Dr. Sacco has been appointed Editor-In-Chief (starting April 2020).

Additionally, Dr. Sacco was honored with the inaugural American Stroke Association (ASA) Edgar J. Kenton III Lecture Award on race-ethnic disparities in stroke. His presentation was entitled *Stroke Disparities: From Observations to Actions*, and discussed how initiatives such as the FSR can be utilized to document stroke disparities and improve patient health.

We also want to congratulate our teammate Dr. Erika Marulanda-Londoño, for winning the Bernard J. Tyson Career Development Award at ISC 2020. Dr. Marulanda-Londoño gave an outstanding presentation on how FSR data has enabled improvement of stroke care in the state of Florida. A well-deserved honor!
